May we extend our greetings to you on the much-needed and long-awaited Premier issue of TANK, an independent journal focusing on the operations and policies of the Military Vehicle Collectors Club (MVCC), lately called IMVCC.

The purpose of TANK is to encourage the restoration of fairness, sanity, and integrity to the governing officials of MVCC. Unfortunately, these essential qualities have beccome very scarce and hard to find in the last two years, and instead have been replaced by ARROGANCE OF POWER, various UNethical and ILlegal acts....too many to list or describe.

Dear Fellow Editors and Collectors,

SUBJECT: Club/Chapter Insurance

For quite a few years now the Board of Directors has noted that very few chapters utilize the National insurance policy in any way, shape or form. The financial return from the chapters on this policy represents less than 25 percent of the cost necessary to run this program. The rest of the cost has had to be passed along to the general members. Because of this dismal record, the Board of Directors has chosen not to fund the National insruance policy.

This policy will expire on July 2, 1986 and will not be renewed. The lack of funding was a decision of the Board of Directors at the Board meeting held in Denver, Colorado, in March, 1986.

After the Board meeting, Herrick pointed out that, contrary to rumors being circulated by some individuals, Club insurance is available to all chapters and has always been.

(At the April 1986 Mid-Year Meeting in Denver the Board of Directors discussed letting the national insurance policy run out after the 1986 International Convention but, side-tracked by the Proving Ground squabble, the Board took no action and the Club insurance policy has remained in force.)
